The teaching load (consisting of both on-campus and online instruction) is generally four to five classes per semester with release from classes to take on other responsibilities and adjustments in load for larger classes.

Responsibilities include, but are not limited to:

- Teach the courses for the core curriculum in the Personal Financial Planning B.S. program
- Actively participate in recruitment for the program
- Support career development activities for students
- Provide service to the department, college, and university
